Dear Ministers,

We are writing to urge Canada to accept recommendations made at its recent Universal Periodic Review (UPR) at the UN Human Rights Council to ensure access to health care without discrimination on the basis of immigration status and to fully implement the decision of the UN Human Rights Committee in Nell Toussaint v Canada CCPR/C/123/D/2348/2014 (30 August 2018).

In this historic decision, the Human Rights Committee found that Canada violated Nell Toussaint's rights to life and non-discrimination when she was denied publicly funded health care due to her irregular immigration status, placing her life at risk and causing long-term harm to her health. The Committee stated that Canada "is under an obligation to take all steps necessary to prevent similar violations in the future."

Canada, however, refused to implement the Committee's decision, stating that it disagrees with the Committee's interpretation of the right to life as requiring measures to ensure access to publicly funded health care, even when life is at risk. Canada's response has attracted condemnation both domestically and internationally. Troublingly, when Nell Toussaint sought to vindicate her rights and challenged Canada's refusal to implement the Committee's decision before the Ontario Superior Court of Justice, Canada filed a motion to dismiss the case. The Ontario Superior Court in 2022 <u>ruled against Canada's motion</u>, observing that Canada's attempt to stop the case from proceeding "does it no pride" as it rests on a pejorative mischaracterization of Nell Toussaint's claim that is unfair and reeks of prejudice against migrants.

Sadly, Nell Toussaint died on January 9, 2023, in the midst of her court challenge. Ministers, we trust you agree that the right to life and access to health care are fundamental human rights that should be equally recognized and protected for everyone in Canada. In the current international context, Canada must set a positive example by recognizing the importance of accountability to international human rights law, including when Canada itself is found non-compliant. We therefore urge you to ensure that Canada accepts the UPR recommendations on access to health care and commits to fully complying with the decision of the UN Human Rights Committee in the Toussaint case.

Thank you for your urgent attention to this critical issue.
